### **Your Privacy Is Important to Us**

CISOs Connect's mission is to create a safe community to connect the world's leading security, risk and privacy professionals to allow them to be more productive and successful. Central to this mission is our commitment to be transparent about the data we collect about you, how it is used and with whom it is shared.

The Company uses a solution called "Hivebrite", which enables the import and export of user lists and data, the management of content and events, the organization of emailing campaigns and opportunity research and sharing as well as the management of funds and contributions of any kind. In this regard, as data controller, the Company is particularly aware and sensitive with regard to the respect of its Users privacy and personal data protection. The Company commits to ensure the compliance of the processing it carries out as data controller in accordance with the applicable provisions of the "Loi n°78-17 dated January 6, 1978, relative à l'informatique, aux fichiers et aux libertés" and the EU Regulation EU 2016/679 regarding data protection dated April 27, 2016.

In order to do so, the Company has put in place an appropriate privacy policy which guarantees an optimal level of protection of its Users' data.

This Privacy Policy applies when you use our Services (described below). Below you'll find how we collect, use and share information as described in this Privacy Policy and Cookie Policy.

#### Introduction

We are a membership only online platform for professionals to securely share information with peers to be more successful. People use our Services to network with their peers on security, privacy and other issues as well as personal professional advancement including ways to promote themselves and find potential business opportunities. Our Privacy Policy applies to any member.

Our registered users ("**Members**") share their professional identities, engage with their peers, exchange knowledge and professional insights, post and view relevant content, learn and find business and career opportunities. Content and data on some of our Services is viewable to non-members ("**Visitors**").



#### **Services**

This Privacy Policy, including our Cookie Policy applies to your use of our Services. Solutions Central uses cookies and other technologies to ensure everyone who uses CISOs Connect has the best possible experience. Cookies also help us keep your account safe. By continuing to visit or use our services, you are agreeing to the use of cookies and similar technologies for the purposes we describe in this policy.

## **Data Controllers and Contracting Parties**

Solutions Central (DBA Security Current) will be the controller of your personal data provided to, or collected by or for, or processed in connection with, our Services; you are entering into the User agreement with Solutions Central.

As a Visitor or Member of our Services, the collection, use and sharing of your personal data is subject to this Privacy Policy (which includes our Cookies policy and other documents referenced in this Privacy Policy) and updates.

### Change

Changes to the Privacy Policy apply to your use of our Services after the "effective date."

Solutions Central ("we" or "us") can modify this Privacy Policy, and if we make material changes to it, we will provide notice through our Services, or by other means, to provide you the opportunity to review the changes before they become effective. If you object to any changes, you may cancel your membership, incurring one month's cancellation fee.

You acknowledge that your continued use of our Services after we publish or send a notice about our changes to this Privacy Policy means that the collection, use and sharing of your personal data is subject to the updated Privacy Policy.

## 1. Data We Collect

#### 1.1 Data You Provide To Us

You provide data to create an account with us.



## Registration

To create an account, you need to provide data including your name, email address and/or mobile number, and a password. You also will need to provide payment (e.g., credit card) and billing information.

## You create your CISOs Connect profile

#### **Profile**

You have choices about the information on your profile, such as your education, work experience, skills, photo, city or area where you reside. You don't have to provide additional information on your profile; however, profile information helps you to get more from our Services, including helping business opportunities find you. It's your choice whether to include sensitive information on your profile and to make that sensitive information viewable to other members. Please do not post or add personal data to your profile that you would not want to be seen by your peers.

# You give other data to us, such as sharing (uploading) a presentation.

## **Posting and Uploading**

We collect personal data from you when you provide, post or upload it to our Services, such as when you fill out a form, (e.g., with demographic data), respond to a survey, or submit a presentation you gave in another setting.

You don't have to post or upload personal data; though if you don't, it may limit your ability to grow and engage with your network over our Services.

#### 1.2 Data From Others

## Others may post or write about you.

#### **Content and News**

You and others may post content that includes information about you (as part of articles, posts,



comments, videos) on our Services. Unless you opt-out, we collect public information about you, such as professional-related news and accomplishments (e.g., patents granted, professional recognition, conference speakers, projects, etc.) and make it available as part of our Services.

#### Customers and partners may provide data to us.

#### **Partners**

We may in some circumstances receive personal data about you when you use the services of our customers and partners, such as employers, prospective employers and applicant tracking systems providing us job application data.

## **Related Companies and Other Services**

We receive data about you when you use some of the other services provided by us or our *affiliates*. For example, you may choose to apply for a job via a post.

#### 1.3 Service Use

We log your visits and use of our Services, including mobile apps.

We log usage data when you visit or otherwise use our Services, including our sites, app and platform technology (e.g., our off-site plugins), such as when you view or click on content (e.g., learning video), perform a search, install or update one of our mobile apps, share articles or apply for jobs. We use logins, cookies, device information and internet protocol ("IP") addresses to identify you and log your use.

## 1.4 Cookies, Web Beacons and Other Similar Technologies

We collect data through cookies and similar technologies.

As further described in our Cookie Policy(a) below, we use cookies and similar technologies (e.g., pixels, tags and device identifiers) to recognize you and/or your device(s) on, off and across different Services and devices. We also allow some others to use cookies as described in our Cookie Policy. You can control cookies through your browser settings and other tools.



#### 1.5 Your Device and Location

We receive data from your devices and networks, including location data.

When you visit or leave our Services (including our plugins or cookies or similar technology on the sites of others), we receive the URL of both the site you came from and the one you go to next. We also get information about your IP address, proxy server, operating system, web browser and add-ons, device identifier and features, and/or ISP or your mobile carrier. If you use our Services from a mobile device, that device will send us data about your location based on your phone settings. We will ask you to opt-in before we use GPS or other *tools* to identify your precise location.

### 1.6 Messages

If you communicate through our Services, we learn about that.

We collect information about you when you send, receive, or engage with messages in connection with our Services.

#### 1.7 Sites and Services of Others

We get data when you visit sites that include our plugins, ads or cookies.

We receive information about your visits and interaction with services provided by others when visit others' services that include our plugins ads, cookies or similar technologies.

### 1.8 Other

We are improving our Services, which means we get new data and create new ways to use data.

Our Services are dynamic, and we often introduce new features, which may require the collection of new information. If we collect materially different personal data or materially change how we use your data, we will notify you and may also modify this Privacy Policy.

#### 2. How We Use Your Data

We use your data to provide, support, personalize and develop our Services.



How we use your personal data will depend on which Services you use, how you use those Services and the choices you make in your settings. We use the data that we have about you to provide and personalize, including with the help of automated systems and inferences we make, our Services so that they can be more relevant and useful to you and others.

#### 2.1 Services

Our Services help you connect with others, learn about security, privacy and risk by leveraging your peers and find work and business opportunities, stay informed, get training and be more productive. We use your data to authorize access to our Services.

### **Stay Connected**

Our Services allow you to stay in touch and up to date with colleagues, and other professional contacts.

### **Stay Informed**

Our Services allow you to stay informed about news, events and ideas regarding professional topics you care about, and from professionals you respect. Our Services also allow you to improve your professional skills or learn new ones. We use the data we have about you (e.g., data you provide, data we collect from your engagement with our Services and inferences we make from the data we have about you), to create and potentially recommend relevant content and conversations on our Services. So, if you let us know that you are interested in a new skill (e.g., by watching a learning video), we will use this information to personalize content in your feed, suggest that you follow groups on our site community, or watch related learning content to help you towards that new skill. We use your content, activity and other data, including your name and picture, to provide notices to your network and others. For example, subject to your settings we may notify others that you have updated your profile, posted a blog or presentation, or took new job.

#### Career

Our Services allow you to explore careers, evaluate educational opportunities, and seek out such opportunities on or off our platform. You can signal that you are interested in changing jobs and share information with your peers and potentially job recruiters. We will use your data to recommend jobs to you and you to recruiters. We may use automated systems to profile and provide recommendations to help make our Services more relevant to our Members, and Visitors. Keeping your profile accurate and up-to-date may help you better connect to others and to opportunities through our Services.



## **Productivity**

Our Services allow you to collaborate and share information with colleagues. Our Services allow you to communicate with other Members and schedule and prepare meetings with them.

#### 2.2 Communications

We contact you and enable communications between Members. We offer settings to control what messages you receive and how often you receive some types of messages.

We will contact you through email, mobile phone, notices posted on our websites or apps, and other ways through our Services, including text messages and push notifications. We will send you messages about the availability of our Services, security, or other service-related issues. We also send messages about how to use the Services, network updates, reminders, job suggestions and promotional messages from us and our partners. You may change your communication preferences any time. Please be aware that you cannot opt-out of receiving service messages from us, including security and legal notices.

We also enable communications between you and other members through our Services, including for example invitations to events, group and messages.

### 2.3 Advertising

We serve you tailored ads both on and off our Services.

We target (and measure the performance of) ads to Members, Visitors and others both on and off our Services directly or through a variety of *partners* (e.g. recruiters), using the following data, whether separately or combined:

Data from advertising technologies on and off our Services, like web beacons, pixels, ad tags, cookies, and device identifiers;

Member-provided information (e.g., profile, contact information, title and industry);

Data from your use of our Services (e.g., search history, feed, content you read, who you follow or is following you, connections, groups\_participation, page visits, videos you watch, clicking on an ad, etc.)



We will show you ads called sponsored content which look similar to non-sponsored content, except that they are labeled "ads" or "sponsored." If you take an action on these ads, your action is associated with your name and viewable by others, potentially including the advertiser.

#### Info to Ad Providers

We do not share your personal data with any third-party advertisers or ad networks for their advertising except for: (i) hashed or device identifiers (to the extent they are personal data in some countries); (ii) with your separate permission (e.g., lead generation form) or (iii) data already visible to any users of the Services (e.g. profile). However, if you view or click on an ad on or off our site or apps, the ad provider will get a signal that someone visited the page that displayed the ad, and they may through the use of mechanisms such as cookies determine it is you. Advertising partners can associate personal data collected by the advertiser directly from you with our cookies and similar technologies. In such instances, we seek to contractually require such advertising partners to obtain your explicit, opt-in consent before doing so.

## 2.4 Marketing

We promote our Services to you and others.

We use data and content about Members for invitations and communications promoting membership and network growth, engagement and our Services. We do not use your name without your permission.

#### 2.5 Developing Services and Research

We develop our Services and conduct research.

## **Service Development**

We use data, including feedback within CISOs Connect, to conduct research and development for the further development of our Services in order to provide you and others with information as well as a better, more intuitive and personalized experience, drive membership growth and engagement on our Services, and help connect professionals to each other and to improve their security while receiving professional opportunity.



#### Other Research

We seek to create better security as well as economic opportunity for Members and to help them be more productive and successful. We use the data available to us to research security, privacy, risk and other ways to bolster their organizations as well as research social, economic and workplace trends such as jobs availability and skills needed for these jobs and policies that help bridge the gap in various industries and geographic areas. In some cases, we work with trusted third parties to perform research, under controls that are designed to protect your privacy. We publish economic and other insights, presented as aggregated data, unless research is conducted with the permission of the contributors to be named, rather than personal data.

## **Surveys**

Polls and surveys are conducted by us and others through our Services. You are not obligated to respond to polls or surveys, and you have choices about the information you provide. You may optout of survey invitations.

### 2.6 Customer Support

We use data to help you and fix problems.

We use the data (which can include your communications) to investigate, respond to and resolve complaints and Service issues (e.g., bugs).

### 2.7 Aggregate Insights

We use data to generate aggregate insights.

We use your data to produce and share aggregated insights that do not identify you. For example, we may use your *data* to generate statistics about our members, their reporting structures in the industry.

## 2.8 Security and Investigations

We use data for security, fraud prevention and investigations.



We use your data (including your communications) if we think it's necessary for security purposes or to investigate possible fraud or other violations of our User Agreement or this Privacy Policy and/or attempts to harm our Members or Visitors.

#### 3. How We Share Information

#### 3.1 Our Services

Any data that you include on your profile and any content you post or social action (e.g. likes, uploaded content, comments, messages) you take on our Services will be seen by others.

#### **Profile**

Your profile is fully visible to all Members and customers of our Services. Subject to your settings.

### Posts, Likes, Uploaded Content, Follows, Comments, Messages

Our Services allow viewing and sharing information including through posts, likes, uploading content and comments.

When you share an article or a post (e.g., an update, image, video or article) publicly it can be viewed by everyone and re-shared. Members, potentially Visitors and others will be able to find and see your shared content, including your name (and photo if you have provided one).

In a group, posts are visible to others in the group. Your membership in groups is public and part of your profile, but you can change visibility in your settings.

- We let senders know when you act on their message, subject to your settings where applicable.
- When you like or re-share or comment on another's content (including ads), others will be able to view these "social actions" and associate it with you (e.g., your name, profile and photo if you provided it).

Your employer can see how you use Services they provided for your work (e.g. as a recruiter or sales agent) and related information. We will not show them your job searches or personal messages.

Depending on the enterprise Service, before you use such Service, we will ask for permission to share relevant data from your profile or use of our non-enterprise Services. We understand that certain activities such as job hunting and personal messages are sensitive, and so we do not share those with your employer unless you choose to share it with them through our Services (for example, by applying for a new position in the same company or mentioning your job hunting in a message to a co-worker through our Services).

#### 3.2 Others' Services

You may link your account with others' services, e.g. LinkedIn and Twitter so that they can look up your contacts' profiles.

#### 3.3 Service Providers

We may use others to help us with our Services.

We use others to help us provide our Services (e.g., maintenance, analysis, audit, payments, fraud detection, marketing and development). They will have access to your information as reasonably necessary to perform these tasks on our behalf and are obligated not to disclose or use it for other purposes.

#### 3.4 Legal Disclosures

We may need to share your data when we believe it's required by law or to help protect the rights and safety of you, us or others.

It is possible that we will need to disclose information about you when required by law, subpoena, or other legal process or if we have a good faith belief that disclosure is reasonably necessary to (1) investigate, prevent, or take action regarding suspected or actual illegal activities or to assist government enforcement agencies; (2) enforce our agreements with you, (3) investigate and defend ourselves against any third-party claims or allegations, (4) protect the security or integrity of our Service (such as by sharing with companies facing similar threats); or (5) exercise or protect the rights and safety of our Members, personnel, or others. We attempt to notify Members about legal demands for their personal data when appropriate in our judgment, unless prohibited by law or court order or when the request is an emergency. We may dispute such demands when we believe, in our discretion, that the requests are overbroad, vague or lack proper authority, but we do not promise to challenge every demand.

## 3.5 Change in Control or Sale

We may share your data when our business is sold to others, but it must continue to be used in accordance with this Privacy Policy.

We can also share your personal data as part of a sale, merger or change in control, or in preparation for any of these events. Any other entity which buys us or part of our business will have the right to continue to use your data, but only in the manner set out in this Privacy Policy unless you agree otherwise.



## 4. Your Choices & Obligations

#### 4.1 Data Retention

We keep most of your personal data for as long as your account is open.

We retain your personal data while your account is in existence or as needed to provide you Services. This includes data you or others provided to us and data generated or inferred from your use of our Services. Even if you only use our Services when looking for a new job every few years, we will retain your information and keep your profile open until you decide to close your account. In some cases, we choose to retain certain information in a depersonalized or aggregated form.

### 4.2 Rights to Access and Control Your Personal Data

You can access or delete your personal data. You have many choices about how your data is collected, used and shared.

We provide many choices about the collection, use and sharing of your data, from deleting or correcting data you include in your profile and controlling the visibility of your posts. We offer you the ability to control and manage the personal data we have about you.

For personal data that we have about you:

- **Delete Data:** You can ask us to erase or delete all or some of your personal data (e.g., if it is no longer necessary to provide Services to you).
- Change or Correct Data: You can edit some of your personal data through your account. You can also ask us to change, update or fix your data in certain cases, particularly if it's inaccurate.
- **Object to, or Limit or Restrict, Use of Data:** You can ask us to stop using all or some of your personal data (e.g., if we have no legal right to keep using it) or to limit our use of it (e.g., if your personal data is inaccurate or unlawfully held).
- **Right to Access and/or Take Your Data:** *You can ask* us for a copy of your personal data and can ask for a copy of personal data you provided in machine readable form.

You may also contact us using the contact information below, and we will consider your request in accordance with applicable laws.



#### **4.3 Account Closure**

We keep some of your data even after you close your account.

If you choose to close your CISOs Connect account, your personal data will generally stop being visible to others on our Services within 24 hours. We generally delete closed account information within 30 days of account closure, except as noted below.

We retain your personal data even after you have closed your account if reasonably necessary to comply with our legal obligations (including law enforcement requests), meet regulatory requirements, resolve disputes, maintain security, prevent fraud and abuse, enforce our User Agreement, or fulfill your request to "unsubscribe" from further messages from us. We will retain depersonalized information after your account has been closed.

Information you have shared with others (e.g., through comments, updates or group posts) will remain visible after you closed your account or deleted the information from your own profile or mailbox, and we do not control data that other Members copied out of our Services. Groups content and ratings or review content associated with closed accounts will show an unknown user as the source.

### 5. Other Important Information

#### 5.1. Security

We monitor for and try to prevent security breaches. Please use the security features available through our Services.

Built on the Hivebrite platform, Hivebrite implements security safeguards designed to protect your data, such as HTTPS and strong passwords. Hivebrite regularly monitors our systems for possible vulnerabilities and attacks. However, we cannot warrant the security of any information that you send us. There is no guarantee that data may not be accessed, disclosed, altered, or destroyed by breach of any of our physical, technical, or managerial safeguards.

The data of the Users are accessible only to the persons duly authorized to do so by the Company for administrative or maintenance purposes of the Platform to the exclusion of any commercial use, and if applicable, in order to enforce the rights exercised by the Users regarding their data (in particular the right to access, rectify, oppose, port and to be forgotten).



The Company informs the User that, outside of hosting and payment services, it uses the following subcontractor:

Especially in light of any future developments of the applicable legislation and regulations, the Company reserves its right to proceed with any modification of its privacy policy and commits to duly inform you if any such modification occurs.

### 5.2. Cross-Border Data Transfers

We store and use your data outside your country.

We process data both inside and outside of the United States and rely on legally-provided mechanisms to lawfully transfer data across borders. Countries where we process data may have laws which are different, and potentially not as protective, as the laws of your own country.

### 5.3 Lawful Bases for Processing

We have lawful bases to collect, use and share data about you. You have choices about our use of your data.

At any time, you can withdraw consent you have provided by going to settings.

We will only collect and process personal data about you where we have lawful bases. Lawful bases include *consent* (where you have given consent), contract (where processing is necessary for the performance of a contract with you (e.g. to deliver the CISOs Connect Services you have requested)) and "legitimate interests". Where we rely on your consent to process personal data, you have the right to withdraw or decline your consent at any time and where we rely on legitimate interests, you have the right to object.

### 5.4. Direct Marketing and Do Not Track Signals

Our statements regarding direct marketing and "do not track" signals.

We currently do not share personal data with third parties for their direct marketing purposes without your permission.

## **Cookie Policy**

#### Effective on May 8, 2018

At Solutions Central (DBA Security Current), we believe in being clear and open about how we collect and use data related to you. In the spirit of transparency, this policy provides detailed information about how and when we use cookies. This cookie policy applies to any Solutions Central (DBA Security Current) product or service that links to this policy or incorporates it by reference.

## Does Solutions Central (DBA Security Current) use cookies?

Yes. As described in <u>Section 1.4 of our Privacy Policy</u>, we use cookies and other technologies to ensure everyone who uses Solutions Central (DBA Security Current) has the best possible experience. Cookies also help us keep your account safe. By continuing to visit or use our services, you are agreeing to the use of cookies and similar technologies for the purposes we describe in this policy.

#### What is a cookie?

A cookie is a small file placed onto your device that enables Solutions Central (DBA Security Current) features and functionality. For example, cookies enable us to identify your device, secure your access to Solutions Central (DBA Security Current) and our sites generally, and even help us know if someone attempts to access your account from a different device. Cookies also enable you to easily share content on Solutions Central (DBA Security Current) and help us serve relevant ads to you.

### When does Solutions Central (DBA Security Current) place cookies?

We use cookies on our sites (such as cisosconnect.com) and mobile applications. Any browser visiting these sites will receive cookies from us. We also place cookies in your browser when you visit non-Solutions Central (DBA Security Current) sites that host our plugins or tags.

## What types of cookies does Solutions Central (DBA Security Current) use?

We use two types: persistent cookies and session cookies. A persistent cookie helps us recognize you as an existing user, so it's easier to return to Solutions Central (DBA Security Current) or interact with our services without signing in again. After you sign in, a persistent cookie stays in your browser and will be read by Solutions Central (DBA Security Current) when you return to one of our sites or a partner site that uses our services (for example, our sharing or job application buttons). Session cookies only last for as long as the session (usually the current visit to a website or a browser session).



#### What are cookies used for?

Cookies can be used to recognize you when you visit Solutions Central (DBA Security Current), remember your preferences, and give you a personalized experience that's in line with your settings. Cookies also make your interactions with Solutions Central (DBA Security Current) faster and more secure. Additionally, cookies allow us to bring you advertising both on and off the Solutions Central (DBA Security Current) sites and bring customized features to you through Solutions Central (DBA Security Current) plugins such as our "Share" button.

### What is Do Not Track (DNT)?

DNT is a concept that has been promoted by regulatory agencies such as the U.S. Federal Trade Commission (FTC), for the Internet industry to develop and implement a mechanism for allowing Internet users to control the tracking of their online activities across websites by using browser settings. The World Wide Web Consortium (W3C) has been working with industry groups, Internet browsers, technology companies, and regulators to develop a DNT technology standard. While some progress has been made, it has been slow. No standard has been adopted to this date. As such, Solutions Central (DBA Security Current) does not generally respond to "do not track" signals.

## How are cookies used for advertising purposes?

Cookies and other ad technology such as beacons, pixels, and tags help us serve relevant ads to you more effectively. They also help us provide aggregated auditing, research, and reporting for advertisers, understand and improve our service, and know when content has been shown to you. Note: Because your web browser may request advertisements and beacons directly from third party ad network servers, these networks can view, edit, or set third party cookies, just as if you had requested a web page from their site. Ads served by Solutions Central (DBA Security Current) may also set third party cookies.

If you are logged in on Solutions Central (DBA Security Current), or another Service that references this Cookie Policy or browsing a third party partner site of Solutions Central (DBA Security Current) and one of our cookies on your device identifies you, your usage (such as your browsing behavior) and log data (such as your IP address), will be associated by us with your account as noted in Sections 1.3 and 1.4 of our Privacy Policy. We also use aggregate data from third parties and data from your profile and Solutions Central (DBA Security Current) activity.

If you are a Solutions Central (DBA Security Current) member but logged out of your account on a browser, Solutions Central (DBA Security Current) may still continue to log your interaction with our services on that browser for up to 30 days in order to generate usage analytics for our services, which analytics we may share in aggregate form with our advertising customers.

Unless you clear these cookies from your browser, we may use this information to:

- provide more relevant, interest-based advertising
- provide aggregate reports of ads activity to advertisers and websites hosting the ads
- help website and app owners understand how visitors engage with their sites or apps
